- Candidates must report at the examination centre on the scheduled reporting time and he/she will not be permitted to leave the examination hall before the completion of 60 mins of the Examination **Candidate Reporting Time: 90 Minutes before Exam Start Time Gate Closing Time: 15 Minutes before Exam Start Time.**
- This Admit card is valid only for the stipulated date, shift and time as specified thereon. Candidates will not be eligible to appear in another shift on the same date or any other date, if absent from the scheduled shift.
- The exam will be a computer-based test consisting of multiple-choice questions. Each question will have four answer options to choose from.
- This Admit card must be presented for verification along with Original (not photocopy or scanned copy) valid Govt. Issued Photo- Identity Card (ie. AADHAAR CARD WITH A PHOTOGRAPH/PAN CARD/PASSPORT/DRIVING LICENSE/VOTER'S CARD), ID issued by enrolling ITI/NSTI/Establishment.
- Candidate arriving after Gate Closing Time will not be allowed.
- Candidate without the printed copy of the Admit card will not be allowed.
- Candidates are requested not to write anything on the Admit card.
- No Bio Break is permitted during the examination.
- Candidates will be permitted to appear for the examination only after proper verification by Centre officials. Candidate will be permitted to allotted seats once Verification process is complete and a verified stamp is affixed on their Admit card.
- Any candidate found using any unfair means or in possession of any incriminating material during the test shall be expelled from the examination hall and his/her test would be cancelled.
- With regards to conduct of examination, decision of Test administrator shall be final and binding.
- Non-observance of the instructions mentioned herein or use of any unfair means during the continuance of his/her test will render the Candidate liable to disqualification from the test.
- No request for change in examination centre/shift will be considered under any circumstances.**
- Candidates are advised to locate the examination centre and its accessibility at least a day before examination, so that they can reach the centre on time for the examination.
